

Fund balances as of June 30, 2017: Education: \$528,507, Building: \$344,612, Transportation: \$190,540, and Working Cash: \$146,250. The four Major Fund Balances: \$1,209,909. Total Fund Balance for all funds: \$2,127,024.

The district has \$331,228 more this year compare to last year in the four major funds. The district has \$460,226 more this year compared to last year in total fund balance.
